2. Who should test with Intuitive Overlays?

- 2.1 Testing with Intuitive Overlays should be carried out by eyecare professionals (e.g. optometrists, orthoptists, opticians, ophthalmologists), education professionals (e.g. teachers, educational psychologists), or researchers.
- 2.2 The symptoms that are helped by coloured filters can sometimes result from other optometric problems. Therefore, it is recommended that before using coloured overlays a person has a full eye examination (i.e., with an optometrist).

3. Who can buy Intuitive Overlays?

- 3.1 Usually, coloured overlays are purchased for or by one of the professionals listed in 2.1.
- 3.2 Coloured overlays can be bought by members of the public, but I.O.O. Sales Ltd recommends that this only takes place after testing by one of the professionals listed in 2.1 and after other causes of symptoms have been excluded as recommended in 2.2.

4. Medical/Optometric assistance

- 4.1 As noted above, Intuitive Overlays do not replace the need for optometric testing or for, when required, conventional optometric appliances (e.g., spectacles).
- 4.2 If you have any specific questions about any ocular or medical matter, you should consult your optometrist or other professional healthcare provider in the first instance.
- 4.3 You should never delay seeking medical care or disregard medical advice.
